the 9/11 terror attacks perpetrated against the United States. It is one of several CBP initiatives implemented after 9/11 to achieve the CBP's twin goals of security and facilitation.

Through partnerships and collaboration with members of the trade community the CBP will better secure the international supply chain to the United States in support of its priority Homeland Security mission. This is a voluntary partnership, which helps to streamline the movement of goods into the United States and avoid costly delays on both sides of the border.
